Terms & Conditions.

Code Of Practice For Approved Driving Instructors:

Dave Robson driving school endorses the code of personal conduct, business dealings, advertising & conciliation. We teach a complete driving skills syllabus as recommended by the Driving Standards Agency.

Insurance:

We carry a £3m professional indemnity & £5m public liability insurance. Pupils are covered provided they are duly licensed to drive and are accompanied by or under the direction of our qualified school instructor.

Terms:

Cash payment in full at the start of the lesson.

Cheques only accepted for block bookings of 10 lessons payable to: Dave Robson.

Cash payment in advance for theory and practical test bookings. A £2 booking fee is added for this.

Lesson Fees:

Individual lessons (1 hour).....	£16.00
10 lessons block Pre booked.....	£150.00
5 lessons block Pre booked.....	£80.00
20 Lessons Block Pre Booked.....	£290.00

Booking Lesson Rules:

Should a lesson be re-arranged or cancelled. A minimum of 24 hours notice must be given. Failure to do so without a valid reason will result in a valid claim for an equivalent amount in compensation.

Lesson duration is based on an hourly or 2 hourly session based on the DSA syllabus.

Lessons include door to door collection within geographical limits.

Pupils should allow 10 minutes early or late for appointment to allow for time & travel.

If your instructor is late we will endeavour to add this to the next lesson.

If your instructor arrives & you do not appear a reasonable time will pass before the instructor moves on.

A booked lesson fee will be claimed at the start of the next lesson.

The Official Driving Test:

The Driving Standards Agency consider an Approved Driving Instructor (ADI) responsible for presenting pupils who are fully prepared for and at least driving test standard. When your readiness is doubtful we will endeavour to re-arrange the test date, in exceptional cases as late as the test day itself. We reserve the right to withhold the school car for the driving test. Neither the school nor its employees will be responsible for late arrival for a test, or missing a test appointment.

We conduct a bulb check before the test but will not be responsible for light bulb failure when the test starts.

We are not responsible or liable for tests cancelled by pupils or the examining authorities.

If you insist on taking the test against our advice it will be your responsibility to arrange transport.

Health Declaration:

Pupils must be in good health and not suffering from any medical conditions which prevent them from driving, EG epilepsy or diabetes. You must inform your instructor if circumstances change or any medication is used or prescribed
